- Including the NSF in your will or trust

- Naming the NSF as a beneficiary of a life insurance policy
- Establishing a charitable trust
- Making a beneficiary designation on an investment account

FREQUENTLY ASKED QUESTIONS

Do I need to tell the NSF?

No, but letting us know allows us to thank you and ensure your wishes are understood.

Can I change my plans later?

Yes. Most beneficiary designations and wills can be revised whenever your circumstances change.

Can my gift support a specific program?

Absolutely. You may choose to direct your gift toward an area of greatest need or a specific mission area that is meaningful to you.

Will my gift remain confidential?

Yes. If you prefer, your intentions and gift amount can remain completely confidential.

Choosing to include the NSF in your estate plans is one of the most meaningful gifts you can make. Your generosity helps ensure that future generations of NSW operators and their families will continue to receive the support they deserve.
